Sub:- Re-Engagement of Retired staff in exigencies of services in Ctara/Secunderabad

In terms of Railway Board's letter cited at reference 1 above and PFA/SC's approval vide reference -2 above, it has been decided to fill up a post of Sr.SO(A) in Ctara by re-engagement of staff who have retired from Indian Railways, as shown under:-

Therefore, applications from staff who have retired from Railway Service are called for, to reach this office on or before 21.08.2019

The following terms and conditions may kindly be noted:

1. The scheme is valid upto 01.12.2019.
2. The re-engagement shall be strictly upto 01.12.2019 or attaining the age of 65 years or till the availability of regular candidates which ever is earlier.
3. Maximum upper age limit for re-engagement is 65 years as on 01.12.2019. No re-engaged employee should continue in service beyond 65 years of age.
4. The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/ conduct is found unsatisfactory.

5. The employees removed/dismissed/compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
6. The re-engaged employees are entitled only for monthly remuneration i.e reducing pension from his/her last pay drawn (i.e Basic+DA) at the time of retirement. The monthly remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
7. The re-engaged employees will not be eligible for LAP, Sick Leave except Casual leave applicable as per Railway boards letter no. E(NG) II/2007/RC-4/CORE/1 Pt.I dt. 24.07.2019 and for absence if any, appropriate deduction will be made from the monthly remuneration.
8. The re-engaged employees are not entitled for any other benefits or facilities except the monthly remuneration.
9. The retired employee shall execute an agreement to abide by all the terms and conditions.
10. Re-engagement shall be subject to prescribed medical fitness for the relevant category.
11. Suitability/Competency of the applicant shall be adjudged by nominated committee before their engagement.
12. Copy of any of the following documents should be attached with the application and it is mandatory.
  - a) Service Certificate
  - b) Pensioner Identity card.
  - c) Pension Payment Order
13. The last date for submission of the application is 21.08.2019 staff retired from railways desirous for re-engagement have to submit their application in the prescribed format a Annexure A in CTARA office on or before 21.08.2019.

14. **Sr.SO(A):** The applicant should have exposure to confidential work, in addition to other phases of work.
